【Centum Love • Learn】 Student Financial Support Scheme

Dear Parents/ Guardians,

The school will join the 【Centum Love • Learn】 Student Financial Support Scheme. Students living in subdivided flats or with financial difficulties but not receiving Comprehensive Social Security Assistance (CSSA) will benefit from the support of the Centum Charitas Foundation and the Lee Shau Kee Charitable Foundation to improve their living environment. Each eligible child will receive a financial aid of HKD \$5,000 (inclusive of cash and cash coupons). The specific arrangements are as follows:

I. Beneficiaries:

Students must be Hong Kong permanent residents and

1. live in subdivided flats and **do not** receive comprehensive social security assistance (CSSA) or;
2. have financial difficulties and **do not** receive comprehensive social security assistance (CSSA).

II. Allowance details:

1. Each child will receive HKD \$5,000 (including cash and HomeMarket cash coupons) in an annual allowance of HKD \$2,500 per school term. Applicants are required to fill out an application form each term.
2. The following two categories are supported, including:
 - a) Daily necessities (HKD \$1,000 HomeMarket cash coupons per issue);
 - b) b.1 Tuition fees (Only for courses conducted by **Government Community Centres/Non-Profit Organisations. Receipts are required**) or;
b.2 School supplies (e.g. Textbooks, stationery, shoes and socks, school uniforms, etc...) **Receipts are required** or;
b.3 Online course accessories (such as data SIM cards and school supplies). **Receipts are required.**

III. Notes:

1. If parents are interested in applying, please complete the application form.
2. Parents must keep all receipts. The items on the receipts must meet the above categories of allowance.
3. Parents will be asked to return the receipts to the school for archiving before the end of each term for the funds' verification purpose.
4. The funds reserve the right to make enquiries to the beneficiaries if they fail to make good use of the allowance or to return the receipts each term.
5. If the beneficiary uses the allowance for non-subsidy purposes, the funds will not accept his/ her next application.
6. Parents will be notified of the application result by mid-July at the earliest.
